1	The RFS mentions that the testbed must ensure the ability to utilize PETS like homomorphic encryption tools for Privacy Preserving Record Linkage (PPRL), secure multi-party computing platforms, and potential linkage to validation servers. Is the ability to utilize differential privacy capabilities to the SCET in scope for this RFS? Differential privacy is the state-of-the-art privacy enhancing technology for output privacy and is called out in the AI Executive order released in 2023 as a key capability that organizations in the federal government must evaluate. 3	If the proposed tooling offers an ability for users to analyze data via statistical methods out-of-the-box along with the ability to be provide APIs or export to the specific tools mentioned (such as the Microsoft Office Suite or SUDAAN) in Attachment 1 Section 1.3.2, will the Government accept the proposed OOTB tooling?	Yes, the government can accept the OOTB tooling.
4	Will the SCE require an ATO any phase of the described work? If so, at what phase?	Yes, an ATO is required before Phase 3. This is discussed in section 2.2.2 of the SOW.
5	Will test participants require any level of security clearance? (i.e. EQIP or Special Sworn Status)	Test participants will not be required to become CIPSEA agents or receive any other security designation as only public data will be used.
6	To engage with SMEs and the user audience during the development of the SCE, will OMB clearance be required if 10 or more participants are engaged?	If more than 10 non-federal employees are engaged with for usability testing, then OMB approval will be needed. OMB approval is not needed to engage with federal employees.
7	Will contact information of SCE testbed users be provided by ATI or NCSES to the contractor to reach the desired volume of participants?	The number of users will be determined by the projects that are approved. NCSES will provide the names of participants. The number of potential participants is a maximum and is an estimate. The actual number of users may be lower.
8	Can you say more about the FedRAMP requirement, which seems like a heavy lift, especially with the short timeline on this project?	We anticipate that the environment is going to be used for a variety of data not just within NCSES, but potentially across other Federal agencies as well. Many other statistical agencies require a FedRAMP certified environment to house or utilize their data. It also sets a high standard in terms of data security, which is critical. As a result, we've requested that FedRAMP certification be at the moderate level.
9	If the vendor's proposed tooling offers an ability for users to analyze data via statistical methods out-of-the-box, along with the ability to provide APIs or export to the specific tools mentioned (such as the Microsoft Office Suite or SUDAAN) in Attachment 1 Section 1.3.2, will the Government accept the proposed OOTB tooling?	We're open to possibilities. If you have a solution that you think would meet our requirements, then the answer to that would be yes.
10	Can you please speak to the CIPSEA requirement? Does the organization need to be an agent or staff within the organization?	It is a bit similar. You would be required to become a CIPSEA agent. Your organization would need to develop and sign a security plan. We

	Is this similar to the CIPSEA requirements one obtains for access to data for research purposes?	would provide a template for this plan. Then, each member of your team would need to sign a data use agreement and take a thirty-minute, virtual, online training. The training would need to be taken annually. There could be additional security requirements for your staff if we have data from other agencies that have additional security requirements. We would need to work with the other data-providing agency on their requirements.
11	How was the 3 month development and 2 month testing phase timeline determined?	We are on a rapid development schedule. We have about two years for this platform to be live and we want to maximize it. We also have some projects that will require this platform, so we would like this to be ready when those projects come on board.
12	Given the scope of the RFS, will the government consider extending the response deadline?	The deadline for submissions remains 2/28/2024.
13	Is Privacy preserving record linkage expected to be part of the overall solution?	No in terms of we are not expecting PPRL tools to be made available as part of the overall software package. We want to make sure that solutions such as that can be supported by the platform itself.
14	What datasets are expected to be part of the initial solution for testing?	For testing purposes, the system will be tested with public use microdata files. No restricted use data should be used for the testing of the platform.
15	What is the scope of multiple award?	Each award can have up to \$8.6 million. It could be multiple awards if different vendors have different aspects of the solution. For example, if a vendor can provide a very robust customer service model and another vendor can only support the actual platform itself, that could be a basis for multiple awards. However, we do encourage all vendors to team to provide a total solution.
16	Can you clarify what you mean by 'security clearance'? is this TS or something else?	Gaining a CIPSEA agent status, you do not need a background investigation. We have other statistical agencies that we partner with that do require additional security clearances and we may host data on this platform from an agency that requires additional security clearance.
17	Can you please speak to the requirement to "ensure the ability to utilize homomorphic encryption tools for PPRL?"?	We want to make sure that the platform is robust enough and has the security required to use privacy preserving technology or host software that we may purchase.
18	Can you spell out the acronym that sounds like "SIP-SEE"?	CIPSEA, Confidential Information Protection and Statistical Efficiency Act
19	Can you please clarify what you mean by "Expenditure Based" contract type?	This is like a cost type agreement, such as cost plus fixed fee, cost reimbursable. Another option than firm fixed price.
20	Under section 1.3.2 it reads - Populate the environment with SAS, Stata, SUDAAN, R, and Microsoft Office Suite software for use by approved users. Will these software's be provided by NCSES or is the vendor to include that in its offer price?	Please provide as much as you can in the offer price. We want to make sure we can use a robust suite of software packages on this platform.
21	Can the entire RFS cost proposal be FFP?	Yes, it can be. You can propose your preferred agreement type.
22	Can you elaborate on vendor iteration with NSF DIS?	We do need to have the system to have an ATO. We will be working with you and with our information security staff to make sure all of the security documentation that you provide is in place and meets NSF standards.

23	Will the ramp certification be required at the time of submission?	No, However, we are on a rapid timeline, and we need the system ATO'd within about five months. So just keep that in mind in terms of timing because it can take some time to become FedRAMP certified.
24	Will there be any Government Furnished Equipment provided by the government or does the Offeror need to provide all of this for the SCET (Cloud infrastructure, tools, etc.)?	No GFE. Infrastructure and tools need to be provided by offeror.
25	Is privacy preserving record linkage expected to be part of the overall solution?	No, we are not expecting you to include software that can provide that capability as part of the solution.
26	What types of data would be used for the test bed, and would they differ from a production system?	Once we are done testing, which will be with public use data, the answer is no. We want to be able to use the same type of data in the system that we would in another production system.
27	If an ADC member had non-traditional status and won a previous ADC contract, do they lose that status or are they grandfathered in?	They are grandfathered in. Awards under ADC do not count against that non-traditional definition. More information on this can be found on the ADC website under the FAQ page.
